**Registration** will close automatically when race hits 200 entrants. Do not wait, as it will fill prior to the listed cutoff date. No double entry allowed due to participant limit. The entry fee includes the \$3.75 USAC and \$1 VCA fees.

2016 Virginia BAR winners and Wounded Warriors must email promoter following registration and state category.

\***Youth/Juniors** 6-14 race age, no TT bikes or aero bars allowed as per USA Cycling.

Check-In: Opens at 7:00 a.m. for Youth/Juniors only. 7:30 in “start order” to follow. The event is held rain or shine, no refunds. All entrants must have a current USAC license or MUST purchase a One-Day License at on-line registration. Riders under 18 years of age are required to have a parent's signature. All USAC rules apply Held under USA Cycling permit. Cat 5's are permitted to race in masters Time Trials. Youth and junior (6 mile) racers start at 7:30 other riders start at approximately 8:00 AM with 30 second intervals. Racers are responsible for their start times. Please be at the staging area 5 minutes prior to your start time. Start times will be written on the back of your number. All USAC rules for Time Trials apply. Start times will be sent out Friday March 31.

\*\*1,2-3 Men and Women combined fields for payout only and will be separated for the BAR

**2016 VCA BAR** winners will sign up under BAR winners at BikeReg.

**Wounded Warriors** must sign up under WW to receive free registration, email promoter to change category from there. WW can race any category qualified for, but puts you out of the series.

Cat 5 men and Women/open triathlete winners receive medals, no payout.

\*\*\*NEW VCA Category!! Athena and Clydesdale will have race day weigh in. Allow time.

Course Directions and Description: A flat, out and back course with a u-turn, closed to traffic. The course is the old Highway 17, now a city park called the Dismal Swamp Canal Trail.
